- 1. Apologies for Absence: Coun. Richardson.
- 2. <u>Declarations of Interest:</u> Coun. Walker (Community Centre, Greatham in Bloom).
- 3. Planning applications: a meeting was held last week to discuss the two applications. H/2020/0479, a re-submission at 32 The Grove, Greatham. The council had no objections but were frustrated that the iniyial application was not adhered to in many ways. H/20200372, a re-submission for 18 houses at Hill View, Greatham. The council have sent an in depth analysis strongly objecting to the "new" plans, stressing the many ways in which various local acts are being ignored.
- **4.** <u>Confirm the minutes of the previous meeting:</u> the minutes were accepted as a true record of the meeting. Prop: Coun.Walker Seconded: Coun. Simmonds For 5 Abstetion: 1.
- frustrations were expressed that "no one" appears to be doing anything positive. 5.2

 <u>Disposal of Community Land in Hill View</u>: linked to H/2020/0372 in section 3 above. The outcome of that will decide a course of action on the matter. 5.3 <u>Repairs list items:</u> they have been forwarded to Coun. Loynes for action. 5.4 <u>Bus shelter provision in South Fens:</u>that too is with HBC. One at Felixstowe Road is the first one requested. 5.5 <u>Notice board in The Fens Tesco:</u> the clerk has arranged to put notices re the PC as and when appropriate. 5.6 <u>£100 donation to Fens Residence Association:</u> now the association has disbanded the money will be held over and spent in the South Fens area. 5.7 <u>Petition re South Fens area leaving Greatham PC's area:</u> Residents have now received letters from HBC seeking their views but a frustration is that even though HBC allowed responses by post they did not enclose the promised s.a.e.'s! The clerk would contact HBC with regard to the oversight.
- 6. New Agenda items: 6.1 Budget review: this item returned to the agenda in attempts to "balance out" the distribution of the precept. After much discussion, the acting chair Coun. Ward suggested that the matter was left open until the outcome of the "South Fens petition" was known early in the new year. If the latter was successful then distribution of the precept would be completely different. Coun. O'Brien did feel that the way the review was being conducted was unconstitutional. The clerk was unable to give a definitive answer to this so Coun. Ward proposed the matter was discussed. For 2 Against 2, chair's casting vote gave the result For 3 Against 2. Proposal carried! The acting chair then proposed the suspension of the matter as outlined above. Prop: Coun. Ward Seconded: Coun. O'Brien For 4 Abstention 1.
